#### 1. REASONS FOR UPDATE TO VERSION 2.0.1 (23/11/2015)

The GEOSTAT 2011 V2.0.1 was created due to an error in the Italian grid. The grid cells in Italy in the previous version were shifted by 1km to the West.

### 2. STRUCTURE OF THE GEOSTAT 2011 V2\_0\_1 DOWNLOAD PACKAGE

The folder GEOSTAT\_grid\_POP\_1K\_2011\_V2\_0\_1.7z contains the following files and folders:

- **GEOSTAT\_grid\_POP\_1K\_2011\_V2\_0\_1.csv** the actual population data of the GEOSTAT grid in csv format,. This file contains data that European NSIs provided using national data sources and expertise;
- **GEOSTAT\_grid\_POP\_1K\_2011\_V2\_0\_1\_MD.xml** –INSPIRE metadata in ISO19139 encoding on the GEOSTAT data;
- **GEOSTAT\_grid\_POP\_1K\_2011\_V2\_0\_1\_UsageConditions.pdf** a file describing conditions for access and use of the GEOSTAT population data;
- GEOSTAT\_grid\_POP\_1K\_2011\_CopyRight a folder containing additional, more detailed national usage and license conditions for selected countries. Those conditions prevail over the general conditions laid down in GEOSTAT\_grid\_POP\_1K\_2011\_V2\_0\_1\_UsageConditions.pdf for the corresponding country. Note that the data contained in JRC-GHSL\_AIT-grid-POP\_1K\_2011.csv may be freely used without restrictions.
- **GEOSTAT\_grid\_POP\_1K\_2011\_V2\_0\_1\_QA.pdf** detailed quality information on the data per country;
- JRC-GHSL\_AIT-grid-POP\_1K\_2011.csv the modelled data from JRC and AIT for those countries that could not provide national data: CY, IS, LU, Bosnia and Herzegovina, Serbia, Montenegro, the Former Yugoslav Republic of Macedonia, Andorra, Isle of Man, Monaco, San Marino, Vatican State;
- JRC-GHSL\_AIT\_grid\_POP\_1K\_2011\_MD.xml INSPIRE metadata in ISO19139 encoding on data modelled by the JRC and AIT;
- **JRC-GHSL\_grid\_POP\_1K\_2011\_QA.pdf** quality information on the modelled disaggregated data provided by JRC for countries with missing data.
- Grid\_ETRS89\_LAEA\_1K\_ref\_GEOSTAT\_POP\_2011\_V2\_0\_1.shp an empty grid net spatial grid cell codes used reference grid to the GEOSTAT\_grid\_POP\_1K\_2011\_V2\_0\_1.csv and JRC-GHSL\_AIT\_grid\_POP\_1K\_2011.csv. The grid net was created according to the INSPIRE grid data specifications for European grids. The Grid ETRS89 LAEA 1K ref GEOSTAT 2011 V2 0 1.shp only contains cells that are inhabited. Areas not covered by grid cells are therefore considered not inhabited by residential population for the reference year 2011. For exceptions of this principle please documentation to the country specific quality GEOSTAT grid POP 1K 2011 V2 0 1 OA.

#### 3. ADDITIONAL INFORMATION ON CONFIDENTIALITY DATA TREATMENT

All grid cells with DATA\_SRC = ESTAT/AIT and DATA\_SRC = JRC are modelled and therefore no confidentiality treatment was applied.

The following countries provided the topic total population (TOT\_P) at the place of residence without disclosure control:

AT, BE, BG, CZ, DK, EL, ES, FI, FR, HU, IT, NL, NO, PT, RO, SE, SI, SK, XK (Kosovo<sup>1</sup>).

The following countries applied disclosure control for the topic TOT\_P:

CH, DE, EE, HR, IE, LI, LT, LV, MT, PL, UK, AL

The attribute TOT\_P\_CON\_DT provides further information on the confidentiality treatment per grid cell. If TOT\_P\_CON\_DT equals a number this number gives the threshold below which population counts were not disclosed. TOT\_P\_CON\_DT= 0 indicates that no treatment was applied.

TOT\_P\_CON\_DT = 'other' indicates that another type of treatment was applied e.g. target record swapping. More details on the confidentiality treatment per country can be found in the QA report GEOSTAT\_grid\_POP\_1K\_2011\_V2\_0\_1\_QA.
